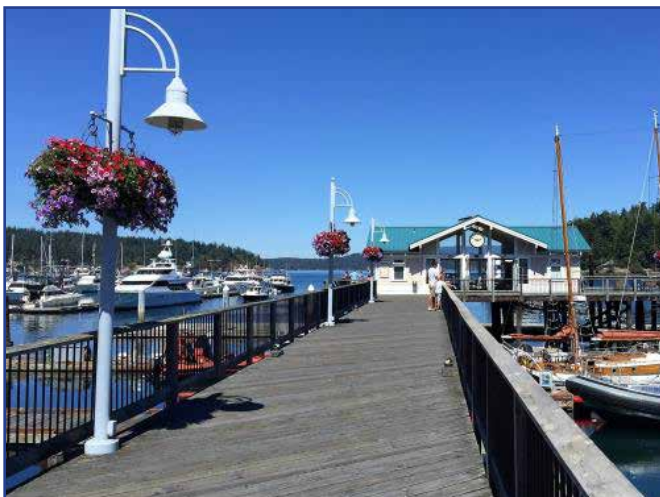
This six night Watercolor Plein Air Workshop offers Eric's expert instruction with the added benefit of shared experiences with fellow watercolor artists. Included:

To reserve this workshop, a **\$500.00** per person deposit with the ***Registration Form** and ***Responsibility Clause** guarantees your attendance. Deposits must arrive by December 30, 2021. Each person attending is required to fill out both documents, sign them and return with their deposit.

CANCELLATION POLICY

If cancellation is requested between the dates of February 1, 2022 and March 1, 2022, all monies will be returned to the applicant minus an administration fee of \$500.00.

If, after March 1, 2022, a cancellation is requested, it must be in writing; no monies will be returned to applicant unless that individual's space can be resold. If the space is resold, all monies will be returned minus an administration fee of \$500.

No refund will be given to an applicant who does not participate or complete the workshop or the field activities.

Eric Wiegardt's Plein Air Workshop reserves the right to cancel the workshop for any reason necessary. All deposits and/or full payments for the workshop will be reimbursed to the participants immediately upon an announced cancellation.
